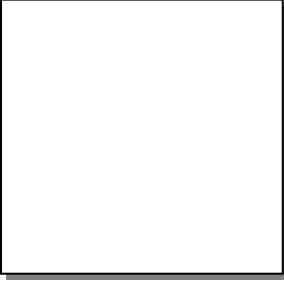

3. Fee case C\$ 25 including (C\$ 5 as bank charges), Draft / M.O.: C\$ 20 in the Consulate General of Pakistan.
4. One Currant photographs.
5. Pre-Paid stamped/Registered envelop for return of documents.
