EMPLOYEES (BPS 1-16), POOR, SHELTERLESS AND LOW PAID CITIZENS
INCLUDING OVERSEAS PAKISTANIS AT CDA DEVELOPED SECTOR I-16/3,
ISLAMABAD**

My Dear,

I take this opportunity to apprise you that in pursuance of vision of the Prime Minister of Pakistan and taking into consideration the suggestions received from numerous Pakistan Missions abroad, PHA has re-launched housing scheme in CDA's developed sector I-16/3, Islamabad. The project is a unique mix of ideal location in close proximity of twin cities and low / affordable cost.

2. The project has been primarily designed for low paid Federal Government employees (BPS 1-16), shelterless and low income group including overseas Pakistanis under the Prime Minister's Housing Programme. In view of the financial constraints of the low paid Federal Government employees, PHA has created cross subsidy in the prices of the apartments for the FG employees. The project details are displayed at website: www.pha.gov.pk. The detail of the apartments is also available in brochure

3. The Prime Minister has desired to include overseas Pakistanis in the housing schemes under the Prime Minister's Housing Programme. I am sending —— brochures cum application forms containing all details about the scheme and price of each brochure is Rs.1,000/-. The applicants shall deposit Rs. 241,000/- as upfront payment with application form along with non refundable enlistment fee of Rs. 10,000/- for FG Employees and Rs. 15,000/- for shelterless and low paid citizen, the amount of which may be remitted in foreign currency directly to PHA Head Office, Ground Floor Shaheed-e-Millat Secretariat, Islamabad or nominated Bank Branches abroad.

4. The Embassy/Consulate General may send the amount of sale of brochure and upfront payment with application form in shape of demand draft of foreign currency on the above address. All payments shall be in favour of "Pakistan Housing Authority". You may also like to keep PHA informed about the response from the prospective buyers along with your suggestions so that additional brochure cum application forms are supplied, if required.

5. I also take this opportunity to request you to kindly give wide publicity of the project among Pakistanis community and staff working in your office. Some Pakistan Banks having Branches abroad have also been engaged for publicity and for provision of brochures & Forms. The list is enclosed for information. It gives me immense pleasure to convey that as per policy decision 40% quota has been fixed for low paid FG employees on concessional rate against which the Embassy staff is also eligible and they can avail the opportunity. The application forms are also available on PHA's web-site which can be downloaded and applicant may also directly forward the application form along with demand draft of amount as stated in para-3 above.
