



PROCEDURE TO TRANSPORT FLOOD RELIEF GOODS FROM TORONTO TO PAKISTAN

PIA WOULD UPLIFT FREE OF CHARGE RELIEF GOODS SUBMITTED THROUGH REGISTERED ORGANIZATIONS ONLY. RELIEF GOODS MAY BE ACCEPTED FOR TRANSPORTATION TO MAJOR PK POINTS IN PAKISTAN I.E. LAHORE, KARACHI, ISLAMABAD FREE OF COST. INTERLINING SECTOR / TRUCKING CHARGES ETC. WILL BE BORNE BY THE SENDER.

- A. RELIEF GOODS MAY PERTAIN OF DRIED MILK FOR CHILDREN AND ADULTS, VEGETABLE OIL, PULSES, WATER COOLERS, BLANKETS, SOAP, ORS (ORAL REHYDRATION KITS), WATER PURIFICATION TABLETS, MOSQUITO NETS, CHILDREN ANTI RASH CREAMS, CANDLES, NON PERISHABLE FOOD ITEMS (HALAL ONLY).

PLEASE NOTE THAT **NO** OLD / USED ITEMS SUCH AS OLD/USED CLOTHES ARE TO BE SENT OR WILL BE ACCEPTED.

- B. PACKING REQUIREMENTS:

PACK RELIEF GOODS IN **STRONG** CARTONS & MENTION CONTENTS OF EACH CARTON.

ITEMIZED LIST FOR EACH CARTON HAS TO BE SECURELY TAPED ON CARTON.

MENTION TOTAL NUMBER OF CARTONS ALONG WITH APPROXIMATE WEIGHT IN THE LETTER OF UNDERTAKING.
